

The Summit School 2019 DC UNITED Raffle Official Rules

The goal of the DC United Raffle is to raise funds for The Summit School, located in Edgewater, Maryland. The Summit School was founded to serve children, grades 1-8, with dyslexia and related learning differences. Now in its 30th year, Summit has an incredible record of helping children become successful learners. The core of Summit's program incorporates: highly trained teachers, evidence based instruction, hands-on, multi-sensory learning environments and small class sizes. The Drawing for the Raffle will take place on June 28, 2019 (the "Drawing Date"). The final ticket purchase deadline for entry is June 28, 2019 at 9:00 am (the "Final Raffle Ticket Purchase Deadline"). Only 350 tickets will be sold. As set forth in the "Prize" section below, only one (1) first place prize will be awarded. The drawing is open to the public and the winner need not be present to win. Winners will be notified immediately following the drawing by email.

Tickets

Raffle tickets cost \$30 per ticket.

An individual U.S. resident over the age of 18 may purchase a Raffle ticket online.

The IRS has taken the position that amounts paid for chances in Raffles, lotteries or similar drawings for valuable prizes are not gifts and therefore do not qualify as deductible charitable contributions.

How to Purchase Tickets

Tickets may be purchased on line at www.thesummitschool.org.

Following receipt of payment for the Raffle Ticket a confirmatory email will be sent to the email address associated with the purchase. Within two (2) business days the purchaser, at the email address associated with the purchase, will be emailed the Raffle Ticket number(s). **There will be no hard copy Raffle Ticket.**

To win a prize, Raffle Ticket Holders do not need to possess a hard copy of a Raffle Ticket or a receipt in order to win and do not need to be present at a drawing. All Raffle Ticket sales are final.

The Summit School assumes no responsibility for lost, late, misdirected, or non-delivered e-mail or fax messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.

The Drawing

For the drawing, The Summit School will draw at random and determine winning Raffle Tickets under the supervision of The Summit School Executive Director or a board member. Drawings will be open to the public, but winners need not be present to win. Drawing will be held at Noon on June 28, 2019 at the Summit School.

Odds of Winning

The odds of winning one or more prizes will depend on the number of tickets sold. If The Summit School sells all 350 tickets, the odds of winning the First Place Prize is 1 in 350.

Fair market value is over \$1,200. Raffle winners will be issued a 1099 in the amount of the fair market value of their prize.

Rules Applicable to All Ticket Buyers and Prize Winner.

Raffle winners must claim the prize within 14 days of the drawing. If the winner does not claim the prize within 14 days of the drawing, by responding to an email notice from The Summit School, the prize will be forfeited.

Each ticket buyer agrees his/her name, likeness, voice and city of residence may be recorded by audio, video, or digital means and may be used in any print, audio or visual media without notice or compensation for any purpose, including related to this or any other promotional materials.

Any and all disputes, claims and controversies concerning this raffle shall be submitted to and resolved by binding arbitration, to be conducted under arbitration rules in the state of Maryland. Prize is not redeemable for cash.

The winners are responsible for all taxes.

Winner will assume and be responsible for all travel expenses, meals, tips, incidentals, and all other fees, and local, state, and federal taxes, including but not limited to all applicable sales, use, luxury, income, and special taxes associated with winning a raffle.
